The duration of Ph.D. programme shall be as follows:

Ph.D. (full-time) with M.Phil.	:	Minimum 2 years and Maximum	4 years
Ph.D. (full-time) without M.Phil.	:	Minimum 3 years and Maximum	5 years
Ph.D. (part-time) with M.Phil.	:	Minimum 3 years and Maximum	5 years
Ph.D. (part-time) without M.Phil.	:	Minimum 4 years and Maximum	6 years

The candidate should submit the **joining report** along with a copy of the fee receipt to the Principal, S.V.U. College of Arts with a copy marked to the Registrar, S.V. University through the guide and the Head of the department on or before 10.12.2015. In case the guide is other than the Department where registered, the joining report is also to be forwarded by the Head of the department where the candidate is registered.

The exact **Topic of Research** is to be finalized within **three months** in case of full-time candidates and **one year** in case of part-time candidates from the date of joining as per the M.Phil./Ph.D. Regulations. A separate order for Topic will be issued later by the principal after finalization of topic in the concerned Departmental Research Committee.

The Candidate admitted into Ph.D. (both Full and Part time) has to sign in the Ph.D. Attendance Register maintained by the concerned Head of the Department. In case the student has registered for Ph.D. (both Full-Time and Part-Time) in parent department with a Research Supervisor from another Department, he/she has to sign the attendance register maintained by the Head of Department where the candidate is working and the candidate can use the facilities in the department of the guide and shall not demand for the facilities in the department where he/she is registered.

A full-time Research scholar shall not study any other full time regular course or take up any occupation. Quarterly progress report and attendance of the Research Scholar should be submitted to the Principal by the concerned Head of the Department. If any full-time scholar is continuously absent for research work in three months without permission from the guide and Head of the department, his/her registration stands cancelled automatically. A Full-Time candidate has to put in a minimum of 75% of attendance in each year until he/she submits his/her thesis.

Every Ph.D. Research Scholar should make a presentation of his /her Research work in a seminar in the department regularly in every six months. Further the Research scholar shall attend two Research seminars & conferences of which one should be in other University/Institute.

The Ph.D. Research scholar shall appear for Ph.D. written examination in two papers. A Full time candidate has to take the Ph.D. written examination after one year of registration whereas a Part-time candidate has to take the Ph.D. written examination after two years from the date of registration.

A Part-time Research scholar has to attend research work in the department at least for 30 days in a year for two consecutive years, and should be in constant touch with the guide, and should submit the progress report every year. The guide in the University (even for candidates registered under external guides) shall send the attendance particulars to the Principal every year.

Note: 1. Hostel accommodation is not available

2. If the candidate is a post graduate from other University, the concerned PG degree get recognized by S.V. University. If the degree is not recognized by S.V. University, the Ph.D. registration gets cancelled.

The duration of Ph.D. programme shall be as followed:

Ph.D. (Full-Time)

Minimum 03 years & Maximum 05 years

There will be no extension of time beyond 5 years. The Registration shall get cancelled automatically if the candidate fails to submit before 5 years. The candidate should submit the joining report along with a copy of the fee receipt to the Dean (R & D) under a copy marked to the Registrar, S.V.University through the Head of the department on or after 30-09-2019 but not later than 25-10-2019.

In case the guide is from a department outside the S V University, the joining report and all the future correspondence should be forwarded by the Head of the department where the candidate is registered, through the concerned Head of the Department in the S V University.

In the case of interdisciplinary research, the candidate shall be awarded the degree in the subject in which he/she registered, mentioning the title of the Thesis. In case of interdisciplinary themes involving two or more disciplines, the Chairperson, Board of Studies (PG-combined) of the subject in which the candidate has registered for Ph.D. shall provide the panel of examiners in addition to the panel given by the Supervisors.

The Candidate shall present seminar within six months to finalize the Ph.D title and shall complete 14 credits before submission of synopsis.

All the research scholars have to be physically present for the teaching classes throughout that semester and shall have to maintain the required 75% of attendance, based on which the candidate will be permitted to write Pre-Ph.D examination. However, if the candidate do not have the required minimum 75% of attendance in the subject, he/she will be detained in those subjects, and shall have to reappear for class-works in those subjects again and then appear for the pre-Ph.D examination as and when it is conducted. There is no revaluation for Pre-Ph.D examination.

The exact title of research programme is to be approved by the colloquium committee before the submission of the thesis. This should be exactly the same, on the thesis copy being submitted, as approved and finalized by the colloquium committee. There should not be any change in the title once it is approved by the colloquium committee.

The registration of a Ph.D. scholar may be cancelled by the Dean, R & D Unit within the stipulated period if the candidate fails to satisfy the conditions stipulated in the admission order or violates the rules and regulations of Ph.D. after giving notice to the concerned candidate. The Dean, R & D Unit may also cancel the registration of a Ph.D. scholar on the recommendation of the Supervisor and or Department Research Committee i.e. a). Where the progress has been reported to be unsatisfactory in two consecutive years / Research Review Meetings. b)Where a candidate discontinues research, and or where they have accepted any of appointment other than specified earlier without the written consent of the Dean, R & D Unit. c) Where the candidate has not submitted the thesis in the stipulated duration of the course and d) where the candidate request for cancellation due to his/her personal reasons.

Admission is in accordance with the SVU Ph.D regulations of 2019. The candidate should abide the regulations in total and any deviation will result for the cancellation of this proceedings. Hostel accommodation is subject to availability.
